SOUTHWEST SEMINAR IN EARLY MODERN PHILOSOPHY 2005 to 2017

The Southwest Seminar in Early Modern Philosophy was co-founded in 2005 by Mary Domski of the University of New Mexico and Don Rutherford of the University of California - San Diego.

Following the model of similar seminars around the U.S. and Canada, the Seminar was formed to foster interaction among scholars who work in various topics in the history of early modern philosophy, a period ranging, roughly, from Montaigne to Kant.

Thanks to the effort of various local organizers, program organizers, and referees, and generous financial support from various academic departments, programs, and schools, ten meetings of the Seminar were held between 2006 and 2017.

For each meeting, there were, on average, roughly fifty-eight abstract submissions from which between five and seven were selected for the program based on a process of blind review.
